THE WORLD AFTER COVID-19

- **Delayed recovery** and **more variants** entering the third year of pandemic
- **Vaccination gap** with 90% countries have not reached WHO's 40% target (2021) and African continent far behind, while some have started the third and fourth dose
- **Uneven economic recovery** between countries left with long-term debt burden and developed economies projected to fully recover by 2023
- Recovery is seen as **zero-sum game**



INDONESIA'S G20 PRESIDENCY

RECOVER TOGETHER, **RECOVER STRONGER**

With the spirit of inclusiveness, stronger and sustainable recovery should be achieved collectively

- Involving G20 members and nonmembers, developing countries, Island nations, the most vulnerable, and multi-stakeholders

A more **open, transparent,** and **accountable** system is required to:

- (1) Create better governance and increase public participation
- (2) Create better response to pandemic and support recovery

On **Transparency** and **Accountability**

- The word “**transparency**” and “**accountability**” mentioned **10** times
- Adopted in issues related to **Financing for Sustainable Development, Energy and Climate, Anti-corruption, and Anti-money Laundering/Countering the Financing of Terrorism and Proliferation**
- Established many **commitments** in tackling **pandemic** and achieving **SDGs**

However, without **good governance**:

- No amount of funding will set the path to prosperity
- No public trust that puts government credibility at stake
- No success in tackling pandemic
