Objective

The SAI20 SOM is a preliminary event leading up to the Annual SAI20 Summit, which the SAI of the G20 host country organizes. This event offers a unique opportunity to discuss topics of interest and relevance to these institutions with the necessary depth and broad participation of SAIs.

Climate Finance Group for Latin America, and the Caribbean (GFLAC):



Sandra Guzman is a specialist in low carbon development and climate finance. She is Founder and General Director of the Climate Finance Group for Latin America and the Caribbean (GFLAC). She holds a PhD in Politics from the University of York in the United Kingdom, a specialization in Sustainable Finance from the University of Oxford and a Masters in Environmental Policy and Regulation from the London School of Economics and Political Science (LSE). She is a specialist in energy and environmental policy and management from the Latin American Faculty

of Social Sciences (FLACSO) and holds a degree in International Relations from the National Autonomous University of Mexico (UNAM). She was General Director of Climate Change Policy at the Mexican Ministry of Environment and Natural Resources (SEMARNAT). She is currently the first Mexican to participate in the Homeward Bound Project on Strengthening Women in Science with whom she visited Antarctica to document the Impacts of Climate Change in that territory.

Energy Transition - Center for Infrastructure Regulation (FGV CERI):



Joisa Dutra Saraiva is a professor of economics who founded and has been directing the Center for Infrastructure Regulation (FGV CERI) at the Getulio Vargas Foundation in Rio de Janeiro since 2011. Previously, she served as a commissioner of the Federal Electricity Regulator from 2005 to 2009. She holds a PhD in Economics from the Getulio Vargas Foundation and was a visiting professor at the Harvard Kennedy School of Government, Harvard University in 2010. She is also a member of the World Economic Forum's Global Future Council platform.

Jose Nabor holds a PhD, Master's and Bachelor's degree in Economics from the National Autonomous University of Mexico (UNAM). Since 2019, by presidential appointment, he has been serving as Executive Secretary of the National Council for the Evaluation of Social Development Policy (CONEVAL). Dr. Nabor has also occupied the position of Coordinator of the Postgraduate Program in Economics of the UNAM.
